**Percentage of HQ Teachers (State Aggregate):** The data represented in the third column is not divided by classes. It is JISD's overall teacher HQ status.

**Percentage of HQ Teachers receiving high quality professional development:** JISD continually provides our teachers with high-quality professional development. The data represented in the fourth column shows that JISD has never failed to meet the state target with respect to providing high-quality professional development.
